Risk management review finds competition issues

The Electricity Authority this week released the <u>preliminary findings</u> of its review of risk management options for electricity retailers. The Authority found "that while there are a range and combination of solutions available to retailers, there is a potential risk to retail competition that the Authority cannot ignore."

The Authority's concerns relate to super-peak hedge contracts, when residential demand is high and wholesale electricity prices can get very high. The Authority states, "while some of the evidence is not conclusive, and scarcity is a factor in the availability of these contracts, we believe there is a risk that some level of gentailer market power could be in play." This was evidenced, for example, with some gentailers not even offering hedges when requested.

Subject to feedback during the current consultation, the Authority and Commerce Commission's <u>Energy Competition Task Force</u> will pick up on the review's analysis as the Task Force considers ways to enable new generators and independent retailers to enter and compete in the market.

Further competition issues highlighted

On the same day the Authority released its preliminary findings on risk management options for electricity retailers, the Authority released an <u>additional report</u> showing that the internal transfer pricing and retail gross margins disclosure regime has little or no benefit in providing assurances about the competitive operation of the electricity market.

Where to from here?

The Authority notes it will reconsider the role of internal transfer prices and the disclosure regime after it finalises the findings from its risk management review. That review itself will sharpen focus on the work of the Energy Competition Task Force.

From an end-consumer perspective, there is a lot of interest in the yet-to-be-announced scope of MBIE's competition review, which will hopefully examine issues from an end-consumer perspective, in addition to the Authority's current work which focuses more on retailers.

MEUG strongly supports a market-based approach. At the end of the day, we are hoping the various reviews and any outcomes provide the needed assurance that consumers can have confidence in the market going forward, and that the market supports and enables an internationally competitive economy.
